Your privacy rights are important to us. Please read this notice carefully to help us protect your privacy.

You are hereby notified that this organization in connection with your transaction(s), may obtain information about you as described in this notice. We will handle this information privately, but in order to process your transaction(s) this information may be disclosed to third parties as provided by law. This notice does not apply to information obtained in a non-financial transaction.

- We collect non-public personal information** about you from the following sources:
